It shall be the duty and obligation of the show giving club to see that a judge, club official, volunteer, or any participant at an event is not subject to indignities. The Conformation Show Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred. #### JUDGING PROCEDURE (Sweepstake)

Judging of the sweepstake will commence at approximately 12:00 noon. However if necessary a later starting time may be announced for any one or more of the rings. Within each group, dogs will be judged in order of age class (sexes combined):

Classes offered: 6-9 months, 9-12 months, 12-18 months

#### RULES & AWARDS (Sweepstake)

All dogs between the age of 6 and 18 months on the day of the sweepstake are eligible to compete, regardless of place of birth. All dogs entered in the sweepstake must be entered in one of the official regular classes of the all breed show on that day. Money received as entry fee for the sweepstake will be pooled and divided as follows:

$1^{st}$ in each class $\dots$

#### WITHDRAWAL OF ENTRIES

CHAPTER 8, SECTION 8.7.1 of the Dog Show Rules states: An exhibitor has the right to withdraw on entry any time up to the closing date and time as published in the premium list. This may be done by telephone, but either written or electronic notification must be received by the Show Secretary no later than the official closing date and time as stated in the premium list. If written or electronic notification is not received, the dog will remain entered in the show. When the premium list indicates that entries will be limited, cancellation of entries will not be permitted.

#### MOVING A CLASS DOG TO THE SPECIALS CLASS

8.9.1 of the Dog Show Rules states: A dog which is INDIVIDUALLY REGISTERED in the records of the CKC and has completed the requirements for a Championship in accordance with these rules but at the time of the closing of entries for a show has not received conformation of the title, may be transferred from one of the regular classes to Specials Only providing the transfer is submitted to the Show Secretary in WRITING by the owner or handler at least ONE HOUR PRIOR TO THE OPENING OF THE SHOW.

Junior Showmanship will be held on Saturday, September 4, 2010 at 12:00 noon. The show secretary will accept entries the day of the competition up to one hour prior to the posted time for competition. No bitches in season are allowed in this competition.

#### PARENTS PLEASE READ THE FOLLOWING:

Keep in mind, that whatever age you child is AS OF DEC 31, 2009. This will be the age category that your child will fall into for the competition year of 2010.

PEE WEE CLASS - This class is for handlers 4 years of age up to 6 years of age as of December 31 of the year preceding the competition year. This class is optional and non-competitive. No placements are to be awarded; only participant ribbons, rosettes and token trophies may be presented.

JUNIOR NOVICE - This class is for handlers 7 to 10 years of age as of December 31 of the year preceding the competition year, who have not won 6 first places in the same class with competition.

JUNIOR OPEN - This class is for handlers 7 to 10 years of age as of December 31 of the year preceding the competition year, who have won 6 first places with competition.

INTERMEDIATE NOVICE CLASS - This class is for handlers 11 to 14 years of age as of December 31 of the year preceding the competition year, who have not won 6 first places in the same class with competition.

INTERMEDIATE OPEN CLASS - This class is for handlers 11 to 14 years of age as of December 31 of the year preceding the competition year, who have won 6 first places with competition and for any handler who has progressed through the Junior Open level and feels that he has enough experience to compete at this level.

SENIOR NOVICE CLASS -This class is for handlers 15 years of age as of December 31 of the year preceding the competition year and up to 18 years of age, who have not won 6 first places with competition in this class. Handlers from the Intermediate levels progress to this class.

SENIOR OPEN CLASS -This class is for handlers 15 years of age as of December 31 of the year preceding the competition year and up to 18 years of age, who have won 6 first places with competition in the Senior Novice Class, and for any handler who has progressed through the Intermediate Open level and feels that he has enough experience to compete at this level.

GENERAL RULES

<u>SECTION 1:</u> A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

<u>SECTION 2:</u> The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:
