JUDGING PROCEDURE

Judging of the All-Breed Puppy Sweepstakes will commence at approximately 12:00 Noon. However if necessary a later starting time may be announced for any one or more of the rings. (See judging program for further details). Breed judging will start again at the scheduled time. Within each group, puppies will be judged in order of age, SEXES COMBINED. 6 to 9 months 9 to 12 months 12 - 18 months

RULES and AWARDS

All dogs between the ages of 6 and 18 months on the date of the show shall be eligible to compete, regardless of place of birth. All dogs entered in the sweepstakes must also be entered in a regular class at the All Breed Show, on the day of the Sweepstakes. Money received as entry fee for the sweepstakes will be pooled and divided as follows:

Best in Sweeps	5% of entry fees received
1 st in each class	25% of entry fees received for that class
2 nd in each class	20% of entry fees received for that class
3 rd in each class	15% of entry fees received for that class
4 th in each class	10% of entry fees received for that class

The remaining 25% of all entry fees will be retained to cover administration cost. Rosettes will be awarded for Best in each Group and Best in Sweepstakes. Flat ribbons will be awarded for first to fourth place in each class. If a dog is required for judging in one of the regular classes, judging of the sweepstakes in that group will be suspended until judging of the regular class has been completed.

JUNIOR HANDLING (Under C.K.C. Rules)

Sunday, May 30, 2010 (noon) - Fee \$1.00

Only dogs entered on Sunday in the show or as Exhibition Only that day, are eligible to be entered in the Junior Competition. Please note that all Junior Handlers must register their dog and pay the applicable fee with the show secretary, at least one hour before scheduled judging. A prize will be awarded to each participant. The Ottawa Junior Kennel Club will donate a Rosette for each class winner. Best Overall Winner, will receive a Special gift donated by Squibs Mercier, Honorary OJKC Executive Member.

CLASSES

Junior Puppy	-A dog between 6 mths of age and under 9 mths on the day of the show
Senior Puppy	-A dog between 9 mths of age and 12 mths on the day of the show.
12 - 18 Months	-A dog between 12 mths of age and 18 mths on the day of the show.
Canadian Bred	-A dog which is born in Canada.
Bred by Exhibitor	-The handler must be the owner/co-owner AND breeder/co-breeder of the dog. The owner/breeder must handle the dog in this class, but need not handle the dog further for awards.
Open Class	-For all dogs.
Specials Only	-Dogs which have a recorded CKC registration or Event Registration Number (ERN) and have attained the required points for Championship Status. Dogs entered in this class will compete for Best of Breed, Best of Opposite Sex and Best Puppy in Breed if eligible.

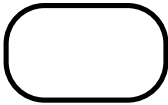

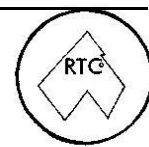

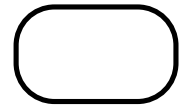

- To comply with instructions issued by the Canadian Kennel Club, we will be unable to accept any entry reaching the Show Secretary after the official closing date as published in this premium list. Section 1 Chapter 13.
- No entry will be accepted unless all particulars called for on the entry form are shown thereon. NO ENTRY WILL BE ACCEPTED UNLESS ACCOMPANIED BY THE ENTRY FEE.
- TELEPHONE ENTRIES WILL NOT BE ACCEPTED.
- Conflicts between Dog Show Rules and New Breed Standards. The Board of Directors of the CKC, has ruled that where there is a conflict between the Breed Standards and the Dog Show Rules that the Dog Show Rules will take precedence.
- Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made. Cancellation of any entry after the closing day is prohibited.
- The Ottawa Kennel Club reserves the right to refuse any entry, subject to C.K.C. Dog Show Rules.
- THE SHOW SUPERINTENDENT WILL BE IN FULL CHARGE OF THE SHOW which will be governed by C.K.C.Rules.
- Identification cards and judging schedule will be mailed as soon as possible after entries close.
- The person accompanying the dog must show the Identification card before the dog is allowed in the show, and unless a dog is entered officially, it will not be allowed in the show precincts.
- All dogs must be exercised in the exercise pens provided for that purpose. Plastic bags will be available at each entrance.
- Dogs need only arrive 15 minutes before scheduled judging time, and will be excused, each show, when not required for further judging. It is the responsibility of the exhibitor to have the dog in the ring when the dog's class is scheduled for judging.
- The Ottawa Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of an accident, or other misfortune, to either dogs, exhibitors or spectators.
- The show will not start before 8:00 am.
- If because of riots, civil disturbance or other acts beyond the control of the management, it is impossible to open or complete the show, no refund of entry fee will be made.
- To avoid noise and confusion, there will be no individual dogs called to the ring by loud-speaker. Delays waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.

CHAMPIONS & CHAMPIONSHIP POINTS

SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder:
