CHAMPIONS & CHAMPIONSHIP POINTS

SECTION 1: A dog awarded WINNERS at a championship show held under these Dog Show Rules shall be credited with a number of championship points (ranging from 0 to 5) and the determination of the number of championship points to be credited to a dog awarded WINNERS shall be as provided hereunder.

SECTION 2: The schedule to be employed in the determination of the number of points to be allocated a dog awarded WINNERS shall be as follows:

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder:

A class dog awarded Best In Show at an all-breed championship show will be credited with five points inclusive of any points earned at the breed or group level. In no case may a dog earn more than five points at any single show.

- No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone and telegraph entries cannot be accepted. Exhibitors must abide by errors made in entering their dogs regardless of how or by whom the entries were made.
- Substitutions or cancellations of any entry after the closing date prohibited. Moving Class Dogs to Specials is permitted. An error in the class, date of birth or sex may be amended on the entry form up to one hour before the start of the show. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration can be entered. The committee reserves the right to refuse any entry subject to CKC Rules
- ENTRIES POSITIVELY CLOSE 9:00 PM TUESDAY, MAY 4TH, 2010** or when limit is reached and must be in the hands of the Show Secretary by that date.
- Identification cards and judging schedules will be mailed as soon as possible after the entries close. Identification cards must be presented upon arrival at the show.
- Tendering of NSF cheques in payment of fees shall be considered non-payment of fees and is punishable by disciplinary actions.
Any N.S.F. cheques will be subject to a \$25.00 service charge.

GENERAL INFORMATION

- The Show Superintendent will be in full charge of the show which will be governed by CKC Rules.
- The Sault Ste. Marie Kennel Club will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume liability in the event of accident, or other misfortunes, to either dogs, exhibitors or patrons.
- If, because of riot, civil disturbance or other acts beyond the control of management, it is impossible to open or to complete the show, no refund of Entry will be made.
- Dogs should arrive in adequate time for their breed judging (allowing for absentees) and will be excused each show when not required for further judging. If dog is not at ringside after it has been called three times, it will be marked absent. It is the responsibility of the exhibitors to have the dog at ringside when the dog's class is scheduled for judging. Waiting for dogs will not be possible and handlers with several breeds must arrange for alternate handlers if judging times for their breeds conflict.
- Judging will commence at 8 a.m. Saturday, May 22, 2010, Sunday, May 23, 2010 and Monday May 24, 2010. A later starting time may be specified in the judging schedule. Starting time of each ring will be specified in the judging schedule.
- Exhibitors are requested to keep their grooming and crating areas clean and tidy. If space is at a premium, exhibitors MUST remove private exercise pens if requested by the Show Superintendent.
SHOW PRECINCTS: The Show precincts shall consist of the Soo Curling Club.

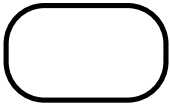
