2. All dogs MUST be exercised in the exercise rings provided for that purpose. Private exercise pens will be allowed if space permits. Exhibitors may be asked to remove private pens during show hours.
3. The Show Committee will use due care and diligence for the welfare of the dogs and the exhibitors but will not be responsible for, or assume any liability in the event of an accident of other misfortune to either dogs or exhibitors or patrons. If, because of riot, civil disturbance or other acts beyond the control of the management, it is impossible to open or to complete the show, no refund of entry fees will be made.
4. The building will open at 7:00 a.m. all three days and will close one hour after completion of judging each day.
5. THERE WILL BE NO INDIVIDUAL DOGS CALLED TO THE RING BY LOUD SPEAKER. Times on the judging schedule will be broken down hourly into individual breeds. Extra copies will be available at the show Secretary's table. It is up to the exhibitor to have his dogs at ringside at the specified time. Delays waiting for dogs will not be possible; handlers with several breeds must arrange for alternate handlers if judging times conflict.

GENERAL

1. Only dogs which are already registered in the Canadian Kennel Club Stud Book, or are eligible for such registration, can be entered.

To determine the numbers of championship points earned by a dog awarded WINNERS total all the dogs in competition which the dog defeated, directly or indirectly, for the highest of the following official breed awards: Winners, Best of Winners, Best of Breed or Best of Opposite Sex and then consult the schedule set forth above. The new system provides for additional points (provided that the dog has defeated another as listed hereunder:
